The Association of Rugby Agents (ARA) is an organisation of individuals and companies engaged in the representation of professional rugby union players in the United Kingdom and Ireland.

The ARA is a non-profit, unincorporated trade body governed by its members under a constitution. It is the only organisation representing rugby agents in the territory.

The aims of the ARA include:

- maintaining a code of professional practice to which all Members of the Association (Members) shall commit themselves;
- discussing matters of common professional interest;
- providing a vehicle for representing the view of rugby agents in discussion of matters of common interest with other professional bodies, the media industry and to the public; and
- Being committed to encouraging the highest ethical standards. All individuals involved in the Association should conduct themselves with integrity, transparency, accountability and in a fair and equitable manner.

Membership

Any agency or individual independent agent shall be eligible for Membership provided they have:

- a place of business within the United Kingdom;
- provided satisfactory evidence to the Committee of their ability to offer the full services of an Agent i.e. they are a registered agent with the RFU; and

- Undertaken to the Committee that they have read and will abide by the constitution of the Association.
- Election to Membership of the Association shall be approved by a majority of the Committee.
- The Committee reserves the right to refuse Membership to any agency or individual who may qualify technically under the conditions set out above.
- Any applicant for Membership who does not technically qualify under the conditions set out above may be accepted for full Membership at the Committee's discretion or may be given observer status for no more than two general meetings if such an applicant is approved by a majority of the full Committee.
- For the avoidance of doubt, there will be no discrimination on grounds of race, gender, occupation, religion or political opinion.
- Any individual agent or agency seeking to join the association shall submit an application to the Committee and, should the application be accepted, payment of the annual subscription shall constitute acceptance of the Association's Constitution. All Members joining the Association shall be deemed to accept the terms of the constitution (and any amendments made hereto) and without prejudice to the foregoing generality, the requirement to conduct themselves in accordance with the Associations ethical framework.
